Postdocs are often expected to complete research objectives, publishing results, and may support and/or contribute expertise to writing grant applications. Appointment durations vary depending on the length of the research project and availability of funding. Total duration of an individual's postdoctoral service may not exceed five years, including postdoctoral service at other institutions.
